REAL ID Means You Are Who You Say You Are: "The hijacker-pilot who flew into the Pentagon, Hani Hanjour, had a total of four driver's licenses and ID cards from three states. Secure and protected identification is critical in our efforts to keep our country and its citizen's safe...From a law enforcement perspective, the concept here gives us that much more confidence that the identification we are looking at is authentic – that you are in fact who you say you are. REAL ID Does Not Infringe On Privacy Rights: "This legislation does not infringe on the privacy rights of any U.S. citizen, nor is it a "national identification card," nor does it create a national database of drivers' licenses. In fact, the model used by the REAL ID Act already exists for commercial drivers' licenses. It is a common sense system that takes the right approach to ensuring the security and authenticity of the most commonly used identity document in the United States—a drivers' license." The American Public Favors Real ID: According to a September 2007 Public Opinion Strategies survey of 800 adults, "82 percent of adults favor a nationwide program for new rules and regulations for state-issued driver's licenses or identification card designed to help prevent terrorism, identity theft and other crimes ... 91 percent of those polled strongly agreed that states should be required to meet national minimum standards for driver's licenses and IDs to make it harder for criminals to use fake IDs to commit crimes, such as identity theft. In other results, 89 percent of those polled would be willing to provide additional identification information to prove their identity for driver's licenses. Eighty-eight percent would be willing to pay additional cost for a new driver's license or other ID if it is more secure and resistant to identity theft and other fraud. Public Opinion Strategies Vice President Jim Burton said, "This is an issue that crosses party, ethnicity, age, region, education, and income lines. There is overwhelming support for new national rules and regulations regarding state-issued driver's licenses and identification cards designed to help prevent terrorism, identity theft and other crimes." Congresswoman Barbara Cubin Sets The Record Straight: "The federal REAL ID program merely establishes a minimum national standard for physical and identity security that states may or may not elect to accept," Cubin explained. "First, the new driver's license will require no additional information that is not already required to apply for or renew a driver's license. Instead, it only strengthens state governments' ability to ensure that applicants are, in fact, who they say they are. Second, the new driver's licenses will allow state and federal law enforcement to check the authenticity of a license, but will not grant access to state databases of private information."
